* Install Gabba turf block postless facility with batting cages on a sideways pulley system, fully retractable for curating and ground maintenance.

*All posts are on either side of the turf block and require no lifting or shifting of any posts. (supplied by other as per Engineer drawings)

*Install and supply all Stainless steel wire and clips with pulley system.
