16. It is the customer's responsibility to ensure sufficient access, equipment, and personnel are available to unload the entire order from the truck.

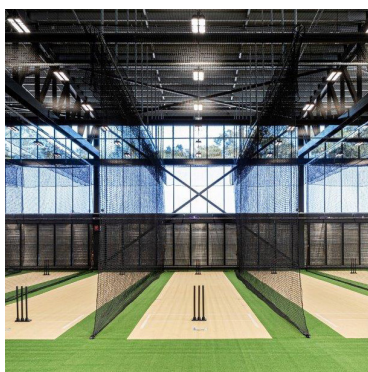
