Demolish & remove the existing 3 lane facility

Set-out of new cricket practice nets

Excavate footings as per AS 1725.4 & AS2870-2011

Install steel reinforcing as AS 1725.4 & AS2870-2011

Install uprights as per AS 1725.4 & AS2870-2011

Slabs & Footings

Footings and reinforcing will be inspected by RPEQ rep. prior to concrete placement.

Install 1 concrete slab 25m long x 19m wide F82 reo, 25 mpa concrete

Install relevant saw cuts

Install 94 L/M black pvc coated 3.15mm heavy duty wire.

100nb end posts, 50 nb mid 32nb top & bottom rails. 3 mid belly cables.

Install 4 club lockable double gates.

Install 5 internal lane nets 25m x 3.6m

Install 1 full safety roof net 19m wide x 25m long

Install 1 back net 15.5m x 3.6m

Install Gabba Grass covering to concrete area 475 sqm

5 Complimentary Beige pitches inc line marking & junior tabs

5 Gabba pitch map coloured line marking
