- 1 x Install concrete slab 10.8m x 30m, Excavate 1% fall for drainage, F82 Reo mesh, 25 MPa concrete 100mm thick, steel trowel finish
 - 1 x Gabba Grass 9.5mm SHIELD 300 with inlaid Beige Test Pitch 10.8m x 30m Installed
 - 13 x Adhesive 20lt
 - Netting installed
 - Install perimeter chain wire security fence, Including posts, top & bottom rails. Powder coated.
 - 1 chain wire lockable double gate(s).
 - 1 chain wire lockable single gate(s).
- Perimeter Chain wire 30m L x 3.6m H x 10.8m H
- PVC Rubber matting down batting end (10.8m)
 - PVC Rubber matting 4 bays long down each side (12.0m)
- Temp safety fencing 100m
- Backfill, topsoil and seed slab surrounds and clean site.

Note: External fencing down each side and middle, double mesh to AS1725.4 2010. Install perimeter chain wire security fence to AS1725.4 2010 including top and bottom rails. Chain link fabric fencing cricket net fencing enclosures.

8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
9. Unless otherwise specified, quotations are based on standard soil conditions for excavation. In the event of rock, hard fill or foreign material being encountered, further costs as required for excavation / earthwork will be applied.

11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
14. In the event of a dispute, the client agrees to provide details of the dispute in writing within 7 days of receipt of our invoice. If no details are provided within this time, all due monies are to be paid as per our agreed trading terms.
