Netting manufactured with double baffle walls and sewn in PVC HT cable tensioned with sports springs chains.

*Full Surface coverage for batting lanes including line markings for batting and bowling,

* Roof Netting full coverage for each lane with drop curtain at bowlers end giving full protection viewing room/ Mezzanine.

* 4 sliding nets to close off each lane for enclosed throw downs or bowling machine work.

All fittings Fitting & accessories including chains to give tensioned perimeter net.

*Extended run-up to all lanes taking the overall surface to 113ft in length.

7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
