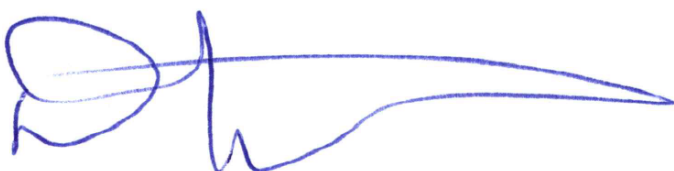
CONDITIONS OF QUOTATION:

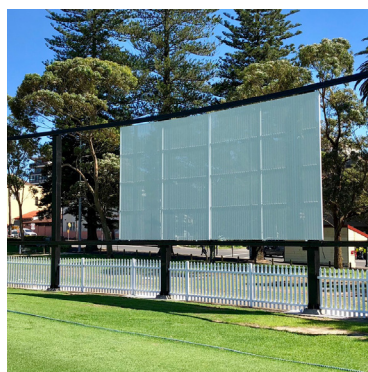
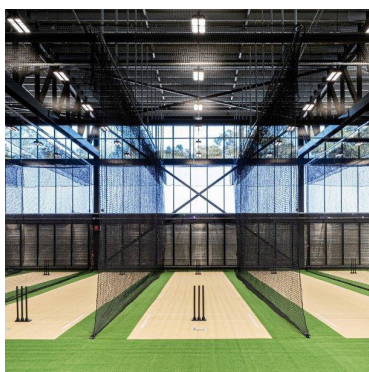
