Demo and remove exist gal chain wire from fence and exist black rubber.

Extend fencing additional 15m (Total 30m runs).

Add top, middle and bottom rails to match existing

Add roof to 15m x 4 lanes.

Add 3 sets of double gates

Re-wire with 3600mm high Black pvc mesh 3.15mm mesh to sides and 2.5mm mesh to roof of 30m x 4 lanes.

Double mesh to all dividers.

Re-instate black impact rubber

80nb end posts, 40nb intermediate posts, 40nb rails " Galvanise.
