8 lane Facility - To bring up to C.A specs

Remove the synthetic surfacing & worn fencing not to CA specs, utilizing the existing slab with an internal extension.

Excavated & install subbase materials 7m x 22 for the internal slab extension & 7.2m x 24m for the side extension from 6 to 8 lanes

Install Engineered slab 7m x 22m for the internal slab extension & 7.2m x 24m for the side extension from 6 to 8 lane x 100mm thick, SL82 reo & saw cuts.

Install 24 engineered posts - powdercoated - Black

Install Gabba Grass 24m long x 28.8m with complimentary beige pitches, senior & Junior line marking

Install 1 fully enclosed safety roof net 28.8m wide x 24m long.

Install 9 x 24m x 3.6m retractable lane nets creating a 692 m2 multi sports use facility. (all posts external)

Install 1 back net 28.8m x 3.6m

5. All variations to contract must be made in writing, signed and approved by an authorised representative prior to additional work commencing.

We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
9. Unless otherwise specified, quotations are based on standard soil conditions for excavation. In the event of rock, hard fill or foreign material being encountered, further costs as required for excavation / earthwork will be applied.

11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
