Site Set-up -Supply, install & maintain up to 120m of safety bunting around the work site.

Permanently display all relevant WHS and works signage on the temp fencing for the duration of the works.

All work to comply with:

Excavate footings as per AS 1725.4 & AS2870-2011

Install steel reinforcing as AS 1725.4 & AS2870-2011

Install uprights as per AS 1725.4 & AS2870-2011

Work in with the existing 3 poles at each end

Footings and reinforcing will be inspected prior to concrete placement

Install 4 x 600mm dia x 3600mm deep footing, reo cages, 32 Mpa concrete.

Install 4 x 10m high x 273 x chs posts dia, black powder coated

Adjust existing Barrier netting to suit

Supply & install black & white mesh sight screens (6m high x 12m wide) on sliding pulley system.

All 5mm stainless steel wire and fittings, 6 plus mm stainless steel wire for curtain suspension.

Clean Up Site

Remove any debris, concrete spoil & rubbish from site

Remove safety fencing
