Gabba Grass Test 36m(118ft) x 12m(39.5 ft)

3 x Gabba Test beige wickets 25m x 2.8m incorporating complete green surrounds to cover total of 36mx12m (432m<sup>2</sup>) as per drawing supplied.

### NETTING

Tensioned perimeter netting and roof 11.5m wide x 36m long x 4.25m high manufactured in 60ply heavy cricket netting.

3 x internal retractable lane nets @ 35m , Eye fittings at 26m

3 x sliding nets to close off each lane for enclosed throw downs or bowling machine work.

Each lane will incorporate lane exit zipper for each lane @ 2.5m height total 3 zippers.

Open hemmed door access with drop net covering at bowlers end for entry of both patrons and ball machines.

All fittings Fitting and accessories including tensioned perimeter net fixed to lbeams and c purlins as per clients specs.

Gabba Synthetic surface will cover the complete surface area and to be trimmed neatly around all columns as necessary.

2. This quotation remains valid for 30 days from the quotation date.
3. If our quotation is accepted, work will be undertaken by employees of Gabba Sporting Products and /or our nominated sub-contractors.
4. The conditions of offer are shown in our quotation and our offer does not imply our willingness to enter into a sub-contract agreement containing conditions that differ from our offer.
5. All variations to contract must be made in writing, signed and approved by an authorised representative prior to additional work commencing.
6. Gabba Sporting Products has built its name on quality products & workmanship, all care will be taken whilst working on site. We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
