 - * Requirement per wicket minimum 3t per wicket (client to supply in 3-5mm dried granuals)
 - * Surface Preparation the concrete base is to be defect free, expansion joints sealed & clean, ready for direct stick surface installation.
 - * Concrete base to have a minimum curing period of one weeks prior to installation of H3 Hybrid Cricket Wicket.
 - * Installation requirements (labor) customer is required to provide access to a minimum of four persons for installation to assist with the installation of the H3 Hybrid Cricket Wicket.
- For the avoidance of doubt, and unless agreed otherwise between the parties, the customer shall be responsible for the installation of the H3 Hybrid Wicket.

Items required over and above for installation:

- * Installation requirements (consumables & equipment rental) customer is required to provide the following equipment and materials to facilitate the installation of the H3 Hybrid Cricket Wicket:
- * 16gal of Indoor/Outdoor Carpet and Artificial Turf Adhesive (specifics can be provide by Gabba on purchase order)
- * 3 x 11 in. x 1/8 in. x 1/16 in. Flat Top V-Notch Pro Flooring Trowel with Handle.
- * General tools (power broom, plastic rake x 3, firm bristle brooms x 3.
- * Irrigation tools (hose , hose attachments, etc.
- * .750kg / 1T roller no bigger.

5. All variations to contract must be made in writing, signed and approved by an authorised representative prior to additional work commencing.

We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
9. Unless otherwise specified, quotations are based on standard soil conditions for excavation. In the event of rock, hard fill or foreign material being encountered, further costs as required for excavation / earthwork will be applied.
10. This quote is subject to site inspection. If the work site is found to contain unforeseen obstacles, resulting in need for additional earthwork, structural support etc., this quote will no longer be valid and a new quote will be issued.
11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
14. In the event of a dispute, the client agrees to provide details of the dispute in writing within 7 days of receipt of our invoice. If no details are provided within this time, all due monies are to be paid as per our agreed trading terms.
