Install Gabba Grass Test product 37m x 27m with complementary Beige pitches 24m x 2m.

* Install training crease lines to 6 lanes

* Install 1 fixed tensioned perimeter & top net 37m x 2.6m x 4.5m high
with 2100 x 2100mm openings

* Install 5 retractable lane nets 29,410 x 4500 with heavy 20mm bottom
rope

Fixing to the exposed portal frame, beams, & purlins will be required.

Each main load point will be 2-300kg on the portal frame & 30kg to the purlins. A marked up plan can be provided to head contractor for review.

The concrete slab is to be defect free, expansion joints sealed & clean, ready for direct stick surface installation.

This fit out is to be one of the last trades to go in & will require a clear run - time frame of 14 days.
