Tensioned perimeter netting and roof 11.5m wide x 36m long x 4.25m high manufactured in 60ply heavy cricket netting.

2 x internal retractable lane nets @ 35m , Eye fittings at 26m

3 x sliding nets to close off each lane for enclosed throw downs or bowling machine work.

Each lane will incorporate lane exit zipper for each lane @ 2.5m height total 3 zippers.

Open hemmed door access with drop net covering at bowlers end for entry of both patrons and ball machines.

All fittings Fitting and accessories including tensioned perimeter net fixed to I-beams and c purlins as per clients specs.
