- Remove 2 lane nets - \$2,400 + GST
- Reduce back net from 14.4m to 7.2m - \$437.50 + GST
- Reduce canopy net from 14.4m to 7.2m - 2,362.50 + GST
- Reduce quantity of posts from 16 to 12 including footings - \$9,080 + GST
- Reduce double gates from 4 to 2 - \$4,000 + GST

Total reduction - \$18,280 + GST

Added components:

- Black coated pvc chain mesh from 66.4m to 142.40m including 20 extra posts and footings - \$46,153 + GST

5. All variations to contract must be made in writing, signed and approved by an authorised representative prior to additional work commencing.
6. Gabba Sporting Products has built its name on quality products & workmanship, all care will be taken whilst working on site. We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
9. Unless otherwise specified, quotations are based on standard soil conditions for excavation. In the event of rock, hard fill or foreign material being encountered, further costs as required for excavation / earthwork will be applied.
10. This quote is subject to site inspection. If the work site is found to contain unforeseen obstacles, resulting in need for additional earthwork, structural support etc., this quote will no longer be valid and a new quote will be issued.
11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
14. In the event of a dispute, the client agrees to provide details of the dispute in writing within 7 days of receipt of our invoice. If no details are provided within this time, all due monies are to be paid as per our agreed trading terms.
15. Notwithstanding the Terms & Conditions outlined above, these terms will not negate any state or federal regulation in any way.
16. It is the customer's responsibility to ensure sufficient access, equipment, and personnel are available to unload the entire order from the truck.
