Manufacture - 2 @ 3 lane cage set up (installed to Gabba postless system) (Cage size 25m x 5m Lanes (15m) x 4m)

Cage netting to suit in heavy duty 60 ply- complete net to be hemmed with 8mm and 20mm rope on bottom and include drop baffles at bowlers end 0.5m

* Supply post system to suit Gabba turf block postless facility to operate batting cages on a sideways pulley system, fully retractable for ease of curating and ground maintenance.

*All structures/ system are set out on either side of the turf block and require no lifting or shifting of any posts. (supplied and installed by Gabba to drawings and design supplied on deposit)

*Supply and install Gabba sleeves and posts to suit - total 26 -posts with lugs and collars , sleeves to suit ground install.

*Supply and install all Stainless steel wire and clips with pulley system for operation.

*Install complete Turf cage set up (2 @ Cage size 25m x 15m x 4m)

NOTE : Additional sleeves supplied and installed for relocation and legacy total 26 pcs @1.5m (within NYC Region)

Freight included in this quotation Port to Port. Not including any dutys, taxes or clearance.

13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
