Lane 1 custom enclosed cage net free hanging inc roof net with heavy drop rope, 4m x 29m.

Bowlers end drop nets for individual bowling machines to meet each lane

Lanes 2,3,4 Full cover roof net CUSTOM Black 45mm 60ply

2 x 30m(99ft) lane nets with tensioned with springs inc roof net full length enclosed.

2 x 30m (99ft) lane net retractable heavy 20mm rope

1 x 9.9 m Back net with tensioned with springs attached to roof net leaving complete cage when lanes are drawn back.

Gabba Grass Test, Full coverage of wicket area 15m (49ft) x 30 (99ft)m -incorporating BEIGE PITCHES

2 x Net zipper entry/exit points for fire requirements at the rear of each cage.
