*Install Gabba Grass Test product 28.3m(93ft) x 21m (69ft) with complementary -Beige pitches 25m x 2.8m. Full Surface coverage

*Install training crease lines to 6 lanes both batting and bowling ends

*Install 1 fixed tensioned perimeter & top net 10.5(34ft)x 28.5(93ft) x 4.0(13ft)m high(lanes 1-3) adding additional 1 roof net and lane for Lane 4 - 3.6 (12ft) x 22(73ft)x4m (13ft)

*Lane 5 & 6 2 lane cage @ 28.3 (93ft) x 7.2 (23ft)

*Bowlers end protection net to cover each lane installed behind bowler.

*Install retractable lane nets 25mx 4.0m with heavy 20mm bottom rope in Heavy 60ply netting.

*All fittings Fitting & accessories including springs to tensioned perimeter net fixed.

Over and above quotation :

2 lanes of Gabba SF10 300 Green Beige @ 4m(13ft) x 25m(100ft) per roll each roll is 4500 USD each roll not including freight.

* The concrete slab is to be defect free, expansion joints sealed & clean, Floor preparation and structure install to be completed by client ready for direct stick surface installation.

5. All variations to contract must be made in writing, signed and approved by an authorised representative prior to additional work commencing.

We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
