Supply and Installation:

30m long x 17m wide

Gabba Grass Test, Full coverage of wicket area 17 x 30 - incorporating BEIGE PITCHES

Tensioned perimeter netting & roof 17m wide x 30m long x 4m high 60ply

4 internal retractable lane nets @ 24m

5 sliding nets to close off each lane for enclosed throw downs or bowling machine work.

Side entry points.

All fittings Fitting & accessories including spring tensioned perimeter net fixed.

Fixing to the exposed portal frame, beams, & purlins will be required.

Each main load point will be 2-300kg on the portal frame & 30kg to the purlins. A marked up plan can be provided to head contractor for review.

The concrete slab is to be defect free, expansion joints sealed & clean, ready for direct stick surface installation

11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
