Glandore Oval - Practice Facility Proposal

The site visit prerequisite was completed with Trent Kelly & Alicia Clutterham from SACA on 6th Feb 2020

Remove the existing bitumen & old chain wire around the decommissioned netball courts

Install a 3 lane synthetic cricket facility on the eastern / South Rd. side.

1 concrete slab 36m long x 10.8m wide

1 open to the public, Gate entry off South Rd & 2 club lanes with soft netting - entry off oval side.

180L/M x 3.6m of black pvc coated fencing.

36L/M x 1.2m of white picket fence to nicely edge the rose garden

36m x 10.8m = 388.8 sqm of Gabba Grass 10mm Test - Complementary beige wickets

Excavate & Install 1 Natural turf wicket block 24m x 24m consisting of 150mm of drainage gravel, 100mm of drainage sand & 150mm of cricket wicket soil.

Excavate & install 1 natural turf run up 12 to 1400 sqm

Irrigation for the natural turf wicket block & run up.

Install 1 Gabba Postless netting system with 4 sliding batting cages
includes stainless fittings & accessories

11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
