 - * Installation requirements (labor) customer is required to provide access to a minimum of four persons to assist with the installation of the H3 Hybrid Cricket Wicket. Alternatively, For the avoidance of doubt, and unless agreed otherwise between the parties, the customer shall be responsible for the installation of the H3 Hybrid Wicket.
- Optional Clay (Australian) \$1000USD per Ton
 - Seafreight Quotation in LCL Cargo not including Clay \$6000 USD Port to Port

5. All variations to contract must be made in writing, signed and approved by an authorised representative prior to additional work commencing.
6. Gabba Sporting Products has built its name on quality products & workmanship, all care will be taken whilst working on site. We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
