Install Gabba Grass Test product 39.98m x 22.5m with complementary Beige pitches 24m x 2m.

Install indoor cricket line marking and Futsal as per CAD Drawings

Install training crease lines to 6 lanes

Install 1 fixed tensioned perimeter & top net 39.98m x 22.5m with 2 x 1900 net openings.

Install 4 retractable lane nets 25m x 4.2m with heavy 20mm bottom rope

Install 1 centre fixed tension net 28,100 x 4200 - option for lift up, opening the area for multi use.

Install 1 front lift up net 21,595 x 4200, split in 2, for use of 1 or 2 courts at anytime.

Fixing to the exposed portal frame, beams, & purlins will be required.

Each main load point will be 2-300kg on the portal frame & 30kg to the purlins. A marked up plan can be provided to AWN for review.

The concrete slab is to be defect free, expansion joints sealed & clean, ready for direct stick surface installation.

This fit out is to be one of the last trades to go in & will require a clear run - time frame of 14 days.
