with drop curtain at bowlers end giving full protection

Install 1 fixed tensioned perimeter & top net 70"x 24" x 12" high
with drop curtain at bowlers end giving full protection

* Italian Sports zippers at batsman's end to meet fire regulations.

*Bowlers end protection net 36" x 12" installed behind bowler + 24"x12".

*Install 3 retractable lane nets 82" x 12"m with heavy 20mm bottom
rope in Heavy 60ply netting.

*5 sliding nets to close off each lane for enclosed throw downs or
bowling machine work.

*All fittings Fitting & accessories including springs to tensioned
perimeter net fixed.

* 1 x Batfast /Simulator Cage Net 56" x 12"x12" installed with all fittings and fixtures - cables and
supports.
