Remove the existing fencing, netting & synthetic grass

leave the existing concrete slabs in place & go over the top, raising the new facility for better drainage.

Install 24 heavy duty posts powder coated black

Install 1 concrete slab 33m wide x 28m long including excavate natural turf out between existing wickets. saw cut between posts.

Install Gabba Grass Green with 6 beige wickets as a complimentary offer. 2 spin wickets & 2 pace wickets

Install 1 full safety roof net

Install 10 heavy duty lane nets 25m x 3.6m

Install 1 heavy duty back net 32.4m x 3.6m
