Excavated & install subbase materials 1.4m x 23.5 (side) & 12m x 14.4m (bowlers) for slab extension

Install Engineered slab 1.4m x 23.5 (side) & 12m x 14.4m (bowlers) for slab extension x 100mm thick, SL82 reo & saw cuts.

Install 101L/M of Black PVC chain wire fencing inc heavy duty posts, rails & 2 double gate entries for players, equipment & bowling machines.

Install rubber protection across the back & 6m up each side

Install Gabba Grass 36m x 14.4m with complimentary beige pitches, senior & Junior line marking

Install 1 full cover safety roof net 36m long x 14.4m wide

Install 5 dividing lane nets 25m long x 3.6m high

Install 1 back net 14.4m wide x 3.6m high

5. All variations to contract must be made in writing, signed and approved by an authorised representative prior to additional work commencing.

We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.

11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
