Gabba Test Indoor Sports surface triple backed to suit Cricket.

1 x Black center wicket with green- beige surrounds.

*Back netting and extra side nets from 92ft - 110ft for both courts x2 @ \$ 2500.00

* Sight Screens Black/ White Screens 50% Shade cloth Backdrop with roman style folding 3 on pulley setup. Court x 2 @ \$9700.00 USD
