PART A - Civil works scope

Site Preparation

- * Installation of temporary fencing
- * SWMS Included
- * Excavation of 15m x 1.5m for new concrete
- * Relocate container to new location
- * Pull up of existing rubber matting
- * Disposal of pulled up synthetic grass & rubber matting

Concreting

- * Existing surface to be ground only in areas if required
- * Slope to be maintained towards lower embankment.
- * Pull down 3 existing gates and reuse if possible
- * 38lm x 3.6m of galvanised chain wire fencing including installation of posts into existing concrete.
- * Install a conduit in coordination with club and electrical contractor. 3.5m long.

Installation of Synthetic Grass

- * Install 2 x 3.6m x 43m & 1 x 4m x 43m Green TEST Synthetic Grass. We can also offer Green & Beige inlet
- * Senior and Junior Tabs
- * Retention existing netting

- * Create a spoon drain between the nets and the embankment with fall towards the northern end.
- * Concrete spoon drain
- * Install storm water pit to collect rainwater

We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
9. Unless otherwise specified, quotations are based on standard soil conditions for excavation. In the event of rock, hard fill or foreign material being encountered, further costs as required for excavation / earthwork will be applied.
10. This quote is subject to site inspection. If the work site is found to contain unforeseen obstacles, resulting in need for additional earthwork, structural support etc., this quote will no longer be valid and a new quote will be issued.
11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
14. In the event of a dispute, the client agrees to provide details of the dispute in writing within 7 days of receipt of our invoice. If no details are provided within this time, all due monies are to be paid as per our agreed trading terms.
15. Notwithstanding the Terms & Conditions outlined above, these terms will not negate any state or federal regulation in any way.
16. It is the customer's responsibility to ensure sufficient access, equipment, and personnel are available to unload the entire order from the truck.
