Site establishment

Manufacture, Supplied, delivered (port to port) & installed.

Not including any duties ,taxes or clearance. (clients responsibility)

1 x Tensioned perimeter netting incorporating bowlers end drop curtain with open bowlers end for runup.

Length: 28 meter

Width: 10.8 meter

Height: 4.5 meter

Playing area will have the capability of pull out 2 lane nets giving 3 lane facility, nets will be 4.5m x 25m length giving full protection from other lanes. all nets have the full scope to retract back on the tensioned wire.

Nets will have Italian Industrial zipper access in the back net for entry and exit.

All the above is inclusive of:

Surface line marking to suit cricket on each court.

1 x Zipper entry points for each court Front and Rear

Gabba Test Indoor Sports surface triple backed to suit Cricket with the option of Beige centre pitches.

Full surface coverage to the playing area of 28m x 10.8m (302m2)

Turf Block System :-

Manufacture - 1 @ 5 lane cage set up (installed to Gabba postless system) (Cage size 66" x 80"x 16") Cage netting to suit in heavy duty 60 ply- complete net to be hemmed with 8mm and 20mm rope on bottom and include drop baffles at bowlers end 0.5m

* Supply Engineering Specs for post system to suit Gabba turf block postless facility to operate postless cages on a sideways pulley system, fully retractable for ease of curating and ground maintenance.

*All structures/ system are setout on either side of the turf block and require no lifting or shifting of any posts. (supplied and installed by Client to drawings and design supplied as part of the order)

*Supply and install all Stainless steel wire and clips with pulley system for operation.

*Install complete Turf cage set up (1 @ Cage size 66" x 80"x 16")

- *TERMS for international 50% on approval, 25% on goods ready for dispatch, final 25% final payment due before Gabba Team arrival for install start.
- * Shipping included from Port to Port
- * All duties clearance and taxes borne by customer.
- * Installation of sports netting cages subject to client providing engineer details/ drawings of structure for installation.
- * Fixing to the exposed portal frame, beams, & purlins will be required.
- * Each main load point will be 2-300kg on the portal frame & 30kg to the purlins.
- * The concrete slab is to be defect free, expansion joints sealed & clean, Floor preparation and structure install to be completed by client ready for direct stick surface installation.

7. It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
8. To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.

11. All soil lifted during excavation will be moved within the grounds, no soil will be removed from the property, a suitable location will be arranged with the grounds staff prior to excavation work starting.
12. Whilst every effort is made to complete the works within a timely manner, deviation from the anticipated time frame may be encountered in unfavourable weather conditions or where unforeseen obstacles are encountered within the site.
13. Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
14. In the event of a dispute, the client agrees to provide details of the dispute in writing within 7 days of receipt of our invoice. If no details are provided within this time, all due monies are to be paid as per our agreed trading terms.
